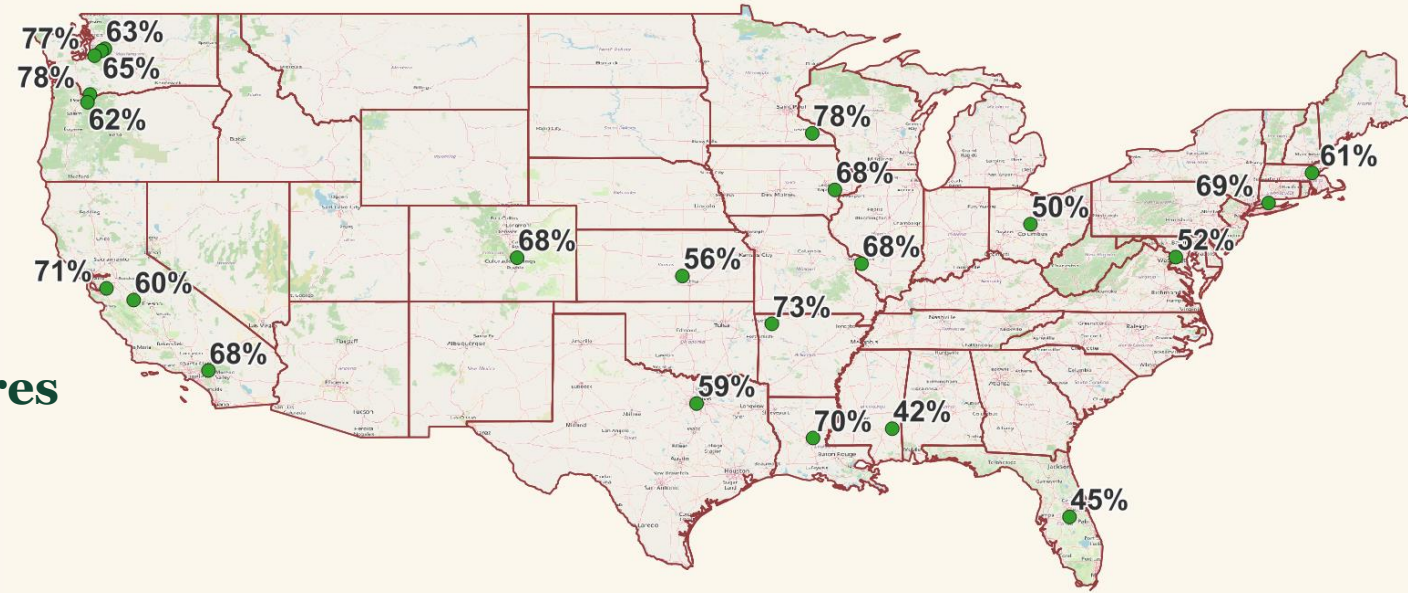

Evaluation Themes and Average Scores



HIGHEST CATEGORIES



- Dedicated Staff Member (82%)
- Authority (82%)
- Community Frameworks (80%)

LOWEST CATEGORIES



- Funding (55%)
- Management Plans (55%)
- Disaster Planning (51%)

Program & Evaluation Factors Impacting Results

HIGHER SCORES



- Established Program & Staffing
- Existing Management Plan
- Proactive Public Tree Maintenance
- Supporting Plans & Policies
- Regional Impacts and/ or Local Opportunities

LOWER SCORES



- Lack of Formal Program
- Budget Undistinguished
- Competing Priorities
- Requirements Met
- Lack of Advisory Board and/or Community Partner

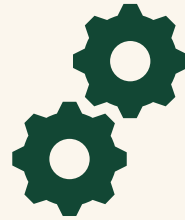
Identified Results of Conducting an Evaluation

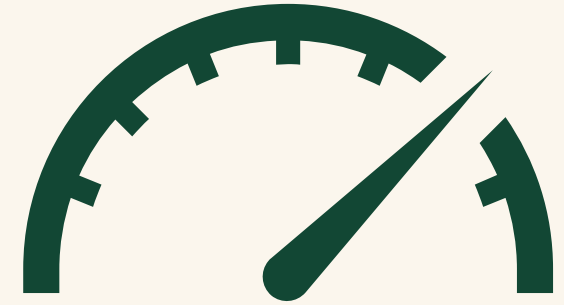
NO EVALUATION EXISTS
